## Membership details

The Club has four categories of membership:

- 1. Full Ordinary members
- 2. Associate members
- 3. Honorary members
- 4. Temporary members

### **Full Ordinary Members**

The following are eligible to be ordinary members:

- Members of the staff of the University; (a)
- Members of the staff of institutions and other bodies affiliated to or connected with the University by (b) statute of the University ("affiliated institutions");
- Full-time students of the University who are candidates for a higher degree by research; and (c)
- Members of the University Council. (d)

#### **Associate Members**

The following are eligible to be associate members:

- Retired members of the staff of the University and of affiliated institutions; (a)
- Alumni of the University; and (b)
- Other persons associated with the University; (c) who in each case are not eligible to be ordinary members.

#### **Honorary Members**

The following are eligible to be honorary members:

- Foundation members, being those members admitted before 31 July 1953; (a)
- Life members, being those persons who have: (b)
  - (i) shown a marked interest in the work of the University; or
  - (ii) rendered distinguished and extended service to the Club; and
  - been invited to accept life membership by resolution of the members in general meeting on (iii) the recommendation of the Committee;
- 50 year members, being those members with 50 years continuous membership. (c)

### **Temporary Members**

The following are eligible to be temporary members:

- Members of other clubs who have reciprocal rights with the Club; (a)
- Visiting staff of other universities; and (b)
- Candidates for admission as ordinary or associate members while their applications are pending. (c)
